## Membership Agreement and Application

### Sales Agreement



**Biz 2 Biz Commerce (B2BC) and the undersigned applicant (member) hereby agree as follows:**

**Sales Agreement:** Member agrees to sell products and/or services to other B2BC members at normal prevailing prices for 100% B2BC trade units. For all unit sales over \$1,500, selling percentages of cash and B2BC trade units become negotiable between the buyer and seller. This must be approved in written contract by both parties before the transaction occurs and a copy of the contract must be submitted to B2BC.

**Sales Limits:** Member can go on standby and temporarily decline further barter sales, only if B2BC is previously notified.

**Membership Fee:** Initial \$295 membership fee is refundable only if B2BC rejects the member application. B2BC reserves the right to reject any application for any reason. The annual renewal of \$90 cash and \$90 B2BC trade will be billed within the membership anniversary month.

**Commissions:** Member agrees B2BC is entitled to its assigned transaction/commission fee of 10% cash on any and every gross sale made by a B2BC member to any other trade member. A gross sale includes any trade or cash portion, excluding tax, shipping, or gratuity. The transaction fee for the trade portion will be assessed and billed upon a B2BC member's purchase from any other trade member. The fee is due within 30 days of the monthly billing statement unless otherwise stipulated to the member in writing.

**Payment Information:** Member agrees that every membership account requires a valid E-mail address and automatic form of payment. (credit card or checking account draft)
